2	Minutes of the last meeting held on 15 th May 2022 –
	The minutes of the last meeting were approved, without amendment, by unanimous vote of the meeting, and there were no matters arising.
3	Electoral Roll reports from St John's & St Luke's –
	St John's – Jean Burton reported that, since the last APCM, 2 people had died and 8 people had joined, giving a current total on the St John's roll of 212.
	St Luke's – Sarah Shepherd reported that one person had died and 3 people had joined, leaving a total on the St Luke's roll of 57.
4 & 5	The Annual Report & Financial Report –
	The Annual Report for 2022, had previously been distributed to attendees. Laura advised the meeting that the Annual Report on church activities and the Financial Report and Accounts for 2022 should really be considered as a single document, and she invited everyone to read through them, if they had not already done so, and

consider any questions. There were no questions arising from the annual report of activities and, in the absence of the PCC Treasurer, Simon was invited to deliver the **Financial Report**, as follows:

Referring to the accounts for 2022, Simon noted that there had been an increase in giving compared to 2021. He thanked all those who give regularly, especially via the parish giving scheme, which, amongst other things, makes gift aid recovery much easier. Our Gift Aid Officer, Andrew McHutchon, is now standing down and Simon thanked him for his diligent work in the role.

It was also noted that income had increased from lettings following a period of downturn during the pandemic and that, overall and without reference to the financial arrangements for the Young People's Worker, the accounts showed a surplus of some £2,000. But outgoings have also increased - on mission giving, parish share payments and energy costs, which will again be higher in the coming year. Building and maintenance costs will also be higher this year as reconstruction work begins on the church hall bell tower. This work will, however, be offset by a generous legacy specifically for improvements to our church buildings. On the subject of the Young People's Worker, Simon advised that there had so far been a good response to the fundraising appeal and it was hoped this will continue in the coming year.

Simon expressed his thanks to Vicky Iley, our new Independent Examiner, who had done a thorough job on the accounts. The figures had been approved but Vicky had noted some changes to the format of the Annual Report which need to be made to fully comply with Charity Commission regulations. He also thanked Belinda Worsell, who has taken over as Payroll Officer, and all those who count the collections each week.

There being no questions on the accounts, Laura thanked David Brown for all his hard work over the year as PCC Treasurer and then also expressed thanks to:

- The Churchwardens for their long and diligent service, including Pat Fenton, who stood down as warden last year but had continued to support Alethea Fry as she started her term of office.
- Our Deanery Synod reps, especially Jane Reichert and Pat Fenton, who were standing down after a number of years in the role.
- Jean Burton and Sarah Shepherd for their work as our Electoral Roll Officers.
- Claire Golightly for her leadership of the Green Team.
- Emma James, for her continuing excellent work as our Young People's Worker.

Message from the Clergy (delivered by the Team Rector and minuted verbatim) –

A few months ago I was talking to a friend who has for some time been struggling with a sense of belonging at the church that he has been part of for many years, with the hiatus that came with the lockdown causing him to look at things with fresh eyes and question what it was like and why he went. And I think that it was his assumption that the church had changed in ways he wasn't comfortable with, but I said to him, 'Maybe it's you who has changed just as much if not more than the church' – for the truth is that we evolve and grow as individuals and thus what suited us once might not suit us in the present.

Now of course, the risk with saying this is that it makes church all about us and not about God and about our playing our part in his family which is the church – but nevertheless the truth is that our relationship with the church is one of constant evolution and it is one that needs working at. So, as we come to this annual meeting, I would ask all of us to take some time over the coming weeks to ask ourselves these questions:

- Do I still love the church/being part of it?
- Did I ever love the church?
- Have I fallen out of love with being part of the church?
- What could I/we do to grow in love for the church?

Now it might seem odd to you that I am talking about our loving the church, but actually, I think to do so should be an integral part of our faith, because the church is not an institution, not a building, but a wonderfully varied family with all sorts of individuals who are our brothers and sisters, with whom we are being built up and becoming, in St Paul's words, 'in every respect the mature body of Him who is the head, that is Christ'.

In other words, we are in this together and, as we work out our questions, and even question our certainties about faith and about the place and role of the church, we need to work out together how God would have us serve him in this place and beyond. So, we really do need each other - we need that mutual support, we need to keep on cultivating an unjudgmental, generous mindset that appreciates and welcomes difference. And this is going to be particularly true as the church as a whole, and the church here in Bilton, works out how to move forward with the opportunity and challenge of being able, in the near future, to offer blessings of same-sex marriages.

And I think this means that I would urge us, in the coming year, to be a church and a people who resist black and white answers, binary approaches that risk separating us from each other, and instead adopt a generous and broad orthodoxy. After all, Jesus only really got cross with those who thought they knew all the answers and stood in judgment over those who didn't think and act like them.

And very practically when it comes to differing perspectives, I want to let you know that from the beginning of next month in both our churches we will be returning to offering the common cup at communion, not least as a sign of our unity. But there will still be some who are uncomfortable at the thought of doing so, thus we will be offering a hybrid model for the time being. I won't go into all the details now, but in the 1st instance at St John's it will mean having two different stations to receive, while at St Luke's those who wish to continue to receive an intincted wafer will be invited to come forward first.
